- Set Budget guidelines for FY 2012-2013 at up to a 3% raise for employees and keeping office budgets at 0% increase. If there is a need to increase an office budget, designate what the increase is for.
- The County Board directed County Attorney, Neleigh Korth to prepare an agreement between Kearney County and Kearney/Buffalo County CASA Program for FY 2012-2013 funding of \$6100.00 for the July 3, 2012 Board meeting.
- Met with John Thorburn of Tri-Basin NRD to discuss 38 Road across Sand Creek. The NRD is looking into building an 18 ft high dam which would have water over a 62 acre area which would be used for recharge and possibly recreational use. The recreational use would be for day use such as picnics or fishing. The County would pay the difference in a standard dam and road structures. The County is interested in looking into the recharge and recreational use idea with a ¾ mile design on 38 Road at no cost to the County.
- Met with Angie Miller, NIRMA contact person. Approved the renewal of the NIRMA policy with a \$2500.00 auto and \$5000.00 Inland Marine Property Damage deductible. Last year was \$91,927.00 and this year is \$96,024.00 for an increase of 4.46%.
- Met with Cletus Holmes of Crossroads Welding who will be having Mud Drags on July 14, 2012 with open coolers. He wanted to let the County know about the event and if there are any regulations he needed to follow. There could be up to 2000 people and parking will be on their property. The Board directed him to talk with the County Attorney and the County Sheriff.
- Met with County Treasurer Barb Lynn and Deputy County Assessor Jennifer Pittner concerning tax statement descriptions. They are working with the programmers to include more of the county bonds separated out on the tax statement. They are limited on the amount of lines they have to use on the statement.
- Met with Randy Smith, Hwy Supt. concerning road matters. Rose equipment will be demonstrating a patch machine. The department has used 300 tons of patch material in the last couple weeks. He reported new rules for people who have CDL Licenses. Cannot be talking or texting on a cell phone but can use a radio. Fuel prices have gone down. The insurance company is making all employees who do not secure their loads liable.
- Met with Scott White, County Sheriff. They have purchased a new police cruiser and received \$1100.00 trade in on the old one. Discussed the probation room at the jail. Scott will contact someone to do the wiring the cameras and internet. Approve a resolution to set up a new fund for 911 Wireless Service Holding Fund and the transfer of 75% of the existing fund balance to save for the purchase of new equipment.

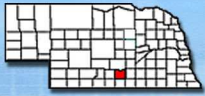

To obtain this Zoning exception, an application for Lot Size Exemption must be filed prior to surveying the lot and verified with documents to confirm eligibility and shall be provided by applicant for approval by the Planning and Zoning Administrator.

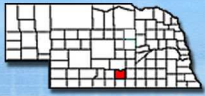

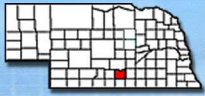

He is asking for money to upgrade the programs and computer system in the Veteran Service Office. The Board decided to add \$4100.00 to the computer budget for that office. He also reported that there needs to be a better way to get information out to Veterans about benefits they may be eligible for. Kearney County is behind in receiving benefits that may be due to Veterans. There needs to be a more streamline way to file for benefits.
- Met with Randy Smith, Hwy Supt. concerning civil rights that need to be addressed so that we can receive Federal Funds. He has visited with Bryan McQuay, County Attorney and will also be contacting NACO and NIRMA to see if they have examples for the legal documents that need to be written.
- Joe Anderson reported on the Tire Cleanup that was held at the Road Dept. There were 192 ton of tires collected at a cost of \$16,382.90 and advertising costs of \$202.50. Department of Environmental Quality will be reimbursing us for \$12,864.00 with the remainder to be split between City of Minden and County of Kearney.
- Tri-County glass gave an update on the Courthouse windows. They were installing two today and they are hoping for the project to be done by November 7, 2012.
- Adjourned the Board of Supervisors meeting at 12:00 p.m.

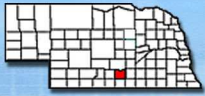

- Set Budget Hearing for FY 2012/2013 for Sept. 11, 2012 at 9:30 and 9:40 a.m.
- Held a discussion on the Veteran Service Office. Many phone calls have been received by Supervisors to leave the Veteran Service Office in the County and not combine with another County.

- Adjourned the Board of Supervisors Meeting at 11:00 a.m.

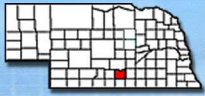
