Boyd Jacobsen asked Joel Kuehn of Kuehn Seeds LLC to present his project to the Planning Commission he explained that they are moving there seed corn business from there place of residence about ½ mile north of this location to this location. They are putting up a 75' x 100' building with 4 bulk seed bins on the south side of the building. They do not plan of taking out any more trees that what they already have to make a driveway into the property.

Board members asked about security on this property since no one is going to live there. Joel stated that they will have cameras and a security system installed.

Zoning Administrator stated that the Highway Superintendent wanted to make sure that there was plenty of parking so there would not be any vehicles parked on the right-of-way.

Zoning Administrator presented a report explain his thought and concerns for the project. Overall this was a fitting location for this type of business and with this being a non-crop area if was not taken any crop land out of production and this is not an ideal location for any residential use due to the close proximity to the highway. And the only concerns that were at this time was the increase of traffic during certain times of year.

Vice Chairman Boyd Jacobsen asked if there was any one else that had any more questions or comments for the board. And with no other questions or comments Boyd Jacobsen called for a motion to close the public hearing. Terry Buettner made a motion to close the public hearing at 8:10 pm Dawn Thompson seconded.
